Entertainment Service Agreement

This agreement is made between The Jim Roberti Trio (further referred to as *The Band*) and **YOUR NAME HERE @ YOUR ADDRESS HERE / YOUR PHONE HERE**.

The Band (**Jim Roberti on acoustic guitar and lead vocals; Gary Wehrkamp on bass, keyboards and backing vocals; Paul Cipriano on drums**) will provide live entertainment on **DATE OF ENGAGEMENT HERE** between the hours of **HOURS HERE**. The entertainment will consist of live music and vocals by *The Band*. *The Band* will be entitled to two twenty-minute breaks during this time period. *The Band* will provide access to its sound system for use with an iPod during breaks.

YOUR NAME HERE agree to remit a deposit in the amount of **50% OF AGREED UPON COMPENSATION HERE** to secure the above date(s) upon signing and returning this contract. The final balance in the amount of **DUE DATE OF REMAINING BALANCE HERE**. In the event of a cancellation of any of the above dates for any reason whatsoever *The Band* will be entitled to payment **IN FULL** for any and all dates canceled within **30** days of said date(s). Any deposits collected by *The Band* are non-refundable within **90** days of the dates stipulated in this agreement. **Overtime requested will be provided solely at the discretion of The Band and will be billed at PRORATED BASED ON ORIGINAL AGREEMENT per additional hour, payable upon completion of the overtime performance. If The Band should not be able to honor this agreement for any reason all deposits will be promptly refunded.**

The Band will provide the sound & light equipment necessary for the performance(s) and **PLACE OF ENGAGEMENT HERE ALONG WITH ADDRESS, NAME AND CONTACT INFORMATION** (the place of engagement) will provide electricity (**2 dedicated 20 amp circuits**). In the event that performances are to be outside, *The Band* will require complete cover from rain and excessive wind, and a **FLAT**, dry area no smaller than **16' wide x 8' deep**. *The Band will not assemble any musical equipment on grass or other damp surfaces. Failure to provide suitable protection against inclement weather conditions (including excessive wind) might pre-empt or cut performances short and The Band will be entitled to payment in full.*

No performance of the engagement(s) shall be recorded, reproduced, or transmitted from the place of performance in any manner or by any means in the absence of a specific written agreement with The Band relating to and permitting such recording, reproduction, or transmission.
